#### **TOWN COUNCIL NEWS**

Merebea Danforth officially resigned from the Council on June 16th. Before moving east to begin a nursing program at John's Hopkins University, Merebea had been a year-round Alta resident and an active community member for eight years. Good luck Merebea!


Elise Morgan was appointed to fill Merebea's Council seat. Elise has been in Alta since 2004, and currently she is Alta Ski Area's front office manager. Elise arrives on the Council having served on the Alta Planning Commission for one year.

Following a public hearing on Tuesday, August 5th, the Alta Town Council approved a **general fund budget** for fiscal year 2014/2015 of \$1,584,617. The budget reflects a certified tax rate of .001200, which generates \$336,274 in property tax.

#### **PLANNING COMMISSION NEWS**

The membership of the Alta Planning Commission has changed significantly. In addition to the resignation of Elise Morgan, now a Town Council member, **Skip Branch** resigned from nearly 25 years of service in June. Skip served



as chair of the Commission from 2003-2012. We will miss Skip's dedication to our community and his critical perspective on issues of development and planning in Alta.

The Planning Commission has been focused on significant revisions to the Town of Alta Base Facilities Zone Ordinance since 2011. In September of 2013, the Town Council received the Planning Commission's recommendations to amend restrictions on building height, lot coverage, yard set-

backs, rooftop mechanical screening, and architectural step-back. In light of new information about possible restrictions on the Town of Alta's culinary water supply system and other considerations, the Town Council remanded these recommendations to the Planning Commission, and in June the two bodies conducted a joint meeting to consider moving forward with new recommendations. The Town Council will hold a public hearing on these recommendations on September 11, and if eventually drafted as new Town ordinanc-

es, the recommendations will allow most current hotel properties in the Town of Alta to expand within their current property boundaries.

Another significant topic on the Planning Commission agenda in recent months has been the possibility of allowing limited condominium development in the Base Facilities Zone.

Condominiums are currently prohibited in the Town's Base Facilities Zone, which is considered Alta's "commercial core." This is a complex issue—stay tuned to future Alta Planning Commission meeting agendas for more discussion.

#### **NEWS AROUND TOWN**

Election day 2014 is November 4th. If you are a registered voter in the Town of Alta, you will be receiving a voteby-mail ballot. There are no Town of Alta positions up for election this year. For more information about this election, please contact the Salt Lake County Clerk's office at 385-468-7400.

Town Staff is working closely with the Forest Service (USFS) and the Bureau of Land Management on the **conveyance** of USFS land to the Town. Parcels include the land under the Bay City Tunnel water building, 1.32 acres west of the Alta Post Office building that is a possible location for a future community center, and the land on which Alta Central and the Town offices are located.

It has been another busy **summer in Albion Basin**, with Summer Booth staff reporting a total of 27,546 cars pass-

ing through the booth as of August 24th, a 22% increase over 2013. The Town operated a free shuttle through Canyon Transportation in 2014, which ran at capacity every day it was offered. Cottonwood Canyons Foundation, the Alta Environmental Center and Friends of Alta provided informational staff at the Albion parking lot and at the upper trailheads, acting as critical resources for the thousands of visitors who come to Alta to experience our spectacular landscape. New for summer 2014 was Alta Ski Lifts operation of the Albion Grill for food service and restroom access, providing summer visitors with valuable amenities.

Alta Ski Area has pursued a significant terrain modification in lower **Collins Gulch**. With the goal of providing an easier way down Collins Gulch, the focus of this project was the widening of the "Corkscrew" ski run, and the removal of the mining overburden pile that has long separated Nina's Curve from Corkscrew. The overburden material was transported uphill into Nina's, which not only opens up space on the lower mountain, but also makes Nina's a more navigable run.

Friends of Alta, the Alta Environmental Center and other partners have hosted several volunteer stewardship events throughout the summer. Projects so far this summer have included significant rerouting and corridor management on the Albion meadows trail; significant re-routing of the Devil's Castle Loop trail, and several invasive weed removal projects. In April, Claire Woodman resigned from six years of service to the Town of Alta as Assistant Town Administrator. Claire's contribution to the Town is difficult to summarize, as she met so many individual responsibilities. Claire has moved into a position with Parametrix, a consulting firm that is coordinating significant aspects of Mountain Accord, a regional planning initiative described elsewhere in this newsletter. We wish Claire good luck!

In May, the Town hired **Chris Cawley** as our new Assistant Town Administrator. Chris brings to the job a broad perspective on issues important to Alta, and he looks forward to serving the community in which he has lived, worked, and played since 2005.



# Message from the Mayor



Summer in Little Cottonwood Canyon has been punctuated by a major roadway construction project: contractors are installing fiber optic technology along the length of Highway 210. I want to thank everyone for their patience with the traffic interruptions caused by this project—when it is completed, our community will have access to state-of-the-art cellular and data connectivity, and our public safety officials will be far better equipped to monitor roadway conditions and com-

municate essential information to the public.

By now, many of you have likely heard of Mountain Accord. As of August, Mountain Accord is deeply engaged in a "systems" approach to planning for the future of the Central Wasatch Mountains, in which large groups of regional experts convene monthly to evaluate future scenarios for the environmental, economic, recreation, and transportation systems. In a nutshell, these "system groups" are creating idealized versions of their own systems, which will be forwarded to a committee of public officials with jurisdiction over the study area, which spans the terrain from I-80 to Little Cottonwood Canyon, and from I-15 to Highway 40 in Summit and Wasatch Counties.

Trying to summarize the scale of this initiative is not easy, but I think it is

helpful to mention a couple of possible proposed actions: establishment of a major new transit corridor in Little Cottonwood Canyon—something like a train, aerial tramway, or bus rapid transit; designation of large portions of the Central Wasatch for conservation, recreation management, or other goals; establishment of user fee systems in high-traffic recreation destinations; and creation of a regional recreation management organization. Make no mistake: Mountain Accord will significantly impact the way we use the Wasatch Mountains, and it could have serious ramifications for the Town of Alta.

Parking: Winter parking regulations will be in effect soon! Cars may ONLY be parked overnight (12AM — 8AM) in DESIGNATED

Vehicle Maintenance: To prevent accidents and allow for better plowing, please dig out cars parked in town within 12 hours of a storm. Noncompliance will result in a citation.

**Dawn Patrol closures:** These closures are issued by the Marshals Office, Unified Police Department, and the U.S. Forest Service and restrict backcountry access to certain areas north

of Hwy 210 when avalanche control work is being planned. Violation of the closure order is a class B misdemeanor. Please respect these closures and help us ensure the safety of avalanche forecasters and backcountry travelers.
