

**Alta Planning Commission Meeting Summary**

**Joan Degiorgio** opened the meeting and indicated the planning commission would spend most of their meeting on a tour of Alta Ski Area led by Alta Ski Area General Manager Onno Wieringa.

**APPROVAL OF MINUTES FROM DECEMBER 5, 2016, FEBRUARY 6, 2017, March 6, 2017, MARCH 13, 2017, and MARCH 20, 2017 ALTA PLANNING COMMISSION MEETINGS**

**Chris Cawley** described circumstances surrounding several sets of previous planning commission meeting minutes which required the planning commission to approve amended minutes from the December 5<sup>th</sup> as well as several sets of minutes from 2017 planning commission meetings. **Roger Bourke** noted that he'd asked Chris to the representation of a comment Roger made during the March 6, 2017 planning commission meeting and that the March 6<sup>th</sup> minutes now reflect Roger's intent.

**Joan Degiorgio** asked for a motion to approve the December 6<sup>th</sup>, 2016 minutes. **Roger Bourke** made a motion to approve these minutes, **Rob Voye** seconded the motion, and the motion was carried. **Joan Degiorgio** asked for a motion to approve the February 6, 2017 minutes. **Rob Voye** made a motion, **Roger Bourke** seconded, and the motion was carried. **Joan Degiorgio** asked for a motion to approve the minutes from the March 6<sup>th</sup>, 2017 meeting. **Jon Nepstad** made a motion, **Roger Bourke** seconded the motion, and the motion was carried. **Joan Degiorgio** asked for a motion to approve the minutes from the March 13<sup>th</sup>, 2016 meeting. **Dave Abraham** stated that he needed more time to review the March 13<sup>th</sup> minutes, and **Joan Degiorgio** agreed that the planning commission should take more time to review minutes from the March 13<sup>th</sup> and March 20<sup>th</sup> planning commission meetings.

**Joan Degiorgio** asked Onno Wieringa to preview the elements he would present to the planning commission during their "ski-around." **Onno Wieringa** suggested that the planning commission should instead adjourn the meeting and reconvene after the tour had begun.

**The Alta Planning Commission joined Alta Ski Area managers for an extensive skiing tour of Alta Ski Area, including a snow cat ride into Grizzly Gulch and rides on several lifts, to view a variety of future**
