**RESOLUTION NO. 2018-R-12**

**A RESOLUTION ESTABLISHING A MAXIMUM NUMBER OF DOG LICENSES WHICH MAY BE ISSUED FOR THE YEAR 2018, FEES TO BE CHARGED AND UNIQUE IDENTIFIER OF LICENSURE**

**WHEREAS**, the Town Council has adopted an Animal Control ordinance which allows for the licensing of dogs within Town boundaries to qualified applicants.

**WHEREAS**, the Town Council shall conduct an annual review related to watershed considerations and licensee compliance and establish limits on the number of dog licenses by resolution.

**WHEREAS**, the Town of Alta's Animal Control Ordinance allows the Town Council to assess fees for annual licensing by resolution.

**WHEREAS**, the Town of Alta's Animal Control Ordinance requires the Town Council to mandate a unique identifier that Alta-licensed dogs must wear in public in order to more readily recognize a legally licensed dog.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL AS FOLLOWS:**

**Section 1.** In consideration of the watershed and newly enacted qualifications for dog licensing, the Town Council finds that an appropriate limit of dog licenses for 2018 is \_\_\_\_\_. ~~Thus, the, which the staff may issue to qualified applicants for calendar year 2018, shall number of dog licenses not exceed~~ (Certified avalanche dogs owned by the Alta Ski Lift Company for avalanche and rescue purposes shall not be counted for purposes of this Section.) Inasmuch as holders of \_\_\_\_\_ licenses have applied for and appear to qualify for renewal, \_\_\_\_\_ licenses to new applicants may be issued.

**Section 2.** Fees for Class A, B, C, F and G licenses shall be as follows: ~~Watershed tag: \$25.00 (one time fee);~~ Female or male dog, annual license: \$125.00; Spayed or neutered dog \$100.00. (No dog will be licensed as spayed or neutered without proof that sterilization was performed.) Class D (temporary) dog licenses issued for two weeks or less: \$50.00 ~~\$50.00 for Town of Alta tag and \$25.00 for watershed tag. Class D licenses for longer than two weeks shall be charged the annual license fee as outlined in this Section 2.~~ Class E licenses shall be charged a fee of \$0 per dog.

**Section 3.** In the event licenses are issued later than January of the year, the license recipient shall nonetheless pay the complete license fee.

**Section 4.** In an attempt to make Alta-licensed dogs more easily recognized when on public property, the dogs shall wear a customized \_\_\_\_\_ that will be designed by the Town of Alta; which cost will be the responsibility of the dog owner.

**Section 5.** This Resolution shall become effective immediately upon passage.
