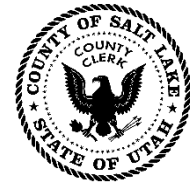

CANDIDATE FILING PERIODS

Qualified Political Party Candidates and Local School Board Candidates

The Declaration of Candidacy filing period for qualified political party candidates begins on Monday, February 28, 2022 and ends at 5:00 p.m., Friday, March 4, 2022. (NOTE: Candidate filing dates were changed per Legislative Bill SB 170 finalized on February 14, 2022.)

Intent to Gather Signatures for Qualified Political Party Candidates

The Declaration of Intent to gather signatures period for qualified political party candidates begins on Monday, January 3, 2022 and ends at 5:00 p.m., Friday, March 4, 2022.

Judicial Retention – Supreme Court, District Court, Juvenile Court and Justice Court Judges

The Declaration of Candidacy filing period for justices and judges of a court of record begins Friday, July 1, 2022 and ends at 5:00 p.m., Friday, July 15, 2022.
